#### SECTION 1 - TERMS AND ABBREVIATIONS

**Aggregator** - A person, firm, corporation, or other legal entity that contracts with the Company for installation of the Company's services. Aggregators make available the Company's services for use by guests, patrons, visitors or other transient third parties at the Aggregator's location. The Aggregator is also responsible for compliance with the terms and conditions of this tariff.

**Authorization Code** - A pre-defined series of numbers to be dialed by the Customer or End User upon access to the Company's system to notify the caller and validate the caller's authorization to use the services provided. The Customer is responsible for charges incurred through the use of his or her assigned Authorization Code.

**Authorized User** - A person, firm, partnership, corporation or other entity who is authorized by the Customer to be connected to and utilize the Carrier's services under the terms and regulations of this tariff.

**Calling Card** - A billing arrangement whereby the originating caller may bill the charges for a call to an approved LEC-issued calling card. The terms and conditions of the local exchange carrier apply to payment arrangements.

**Collect Billing** - A billing arrangement whereby the originating caller may bill the charges for a call to the called party, provided the called party agrees to accept the charges.

**Commercial Credit Card** - A billing arrangement whereby the originating caller may bill the charges for a call to an approved commercial credit card. The terms and conditions of the credit card company apply to payment arrangements.

**Commission** - Refers to the Federal Communications Commission.

Company or Carrier - Custom Teleconnect, Inc., ("CTI") unless otherwise clearly indicated by the context.

**Customer** - A person, firm, partnership, corporation or other entity which arranges for the Carrier to provide, discontinue or rearrange telecommunications services on behalf of itself or others; uses the Carrier's telecommunications services; and is responsible for payment of charges, all under the provisions and terms of this tariff.

### **SECTION 1 - TERMS AND ABBREVIATIONS, (CONT'D.)**

**Customer Dialed Calling Card Call -** A service whereby the End User dials all of the digits necessary to route and bill the call to a calling card.

**Custom Teleconnect**- Used throughout this tariff to refer to Custom Teleconnect, Inc., ("CTI) issuer of this tariff.

**End User** - Any person, firm, corporation, partnership or other entity that uses the services of the Company under the provisions and regulations of this tariff. The End User is responsible for payment unless the charges for the services utilized are accepted and paid by another Customer.

LATA - Local Area of Transport and Access.

**LEC** - Local Exchange Company.

**Mainland United States** - The forty-eight (48) states within the continental United States of America and the District of Columbia.

#### SECTION 1 - TERMS AND ABBREVIATIONS, (CONT'D.)

**Operator Dialed Surcharge** - A charge applying to calls made when the user dials "00" only or any valid company operator access code and requests that the operator dial the destination number.

**Operator Station Call** - A service whereby the caller places a non-Person-to-Person call with the assistance of an operator (live or automated).

**Pay Telephone** - A telephone instrument equipped with a credit card reader, coin box, or similar device that allows charges to be collected for each call at the instrument.

**Person-to-Person Call** - A service whereby the person originating the call specifies a particular person to be reached, or a particular station, room number, department or office to be reached through a PBX attendant.

Personal Identification Number (PIN) - See Authorization Code.

**Switched Access -** Where access between the Customer and the Carrier is provided on local exchange company circuits capable of accessing the local switched network. The cost of switched Feature Group access is billed to the Carrier.

**Third Party Billing** - A billing arrangement by which the charges for a call may be billed to a telephone number that is different from the calling number and the called number.

**Travel Card** - A billing mechanism that enables the Customer to access the service of the Company while away from home or office.

**United States** - For purposes of this tariff the term "United States" includes the Mainland United States of America, Alaska, Hawaii, Puerto Rico, U.S. Virgin Islands, Guam, and the Commonwealth of the Northern Mariana Islands (CNMI).

V & H Coordinates - Geographic points that define the originating and terminating points of a call in mathematical terms so that the airline mileage of the call may be determined. Call mileage may be used for the purpose of rating calls.

#### **SECTION 2 - RULES AND REGULATIONS**

### 2.1 Undertaking of Custom Teleconnect, Inc.

Custom Teleconnect services and facilities are furnished for communications originating at specified points within the United State under terms of this Tariff.

Custom Teleconnect provides for the installation, operation, and maintenance of the communications services provided herein in accordance with the terms and conditions set forth under this Tariff. Custom Teleconnect may act as the Customer's agent for ordering access connection facilities provided by other carriers or entities, when authorized by the Customer, to allow connection of a Customer's location to the Custom Teleconnect services. The Customer shall be responsible for all charges due for such service arrangement.

The Company's services are provided on a monthly basis unless otherwise provided, and are available twenty-four (24) hours per day, seven (7) days per week.

#### 2.2 Use

By:

- **2.2.1** Services provided under this tariff may be used by the Customer for any lawful telecommunications purpose for which the service is technically suited.
- 2.2.2 The services the company offers shall not be used for any unlawful purpose for any use as to which the Customer has not obtained all required governmental approvals, authorizations, licenses, consents, and permits.

#### **SECTION 2 - RULES AND REGULATIONS, (CONT'D.)**

#### 2.3 Limitations of Service

- **2.3.1** Service will be furnished subject to the availability of the necessary facilities and/or equipment and subject to the provisions of this Tariff.
- **2.3.2** The Company reserves the right to discontinue furnishing service when necessitated by conditions beyond its control, or when the Customer is using the service in violation of the provisions of this Tariff, or in violation of law.
- **2.3.3** The Company does not undertake to transmit messages, but offers the use of its facilities when available, and will not be liable for errors in transmission or for failure to establish connections.

### 2.4 Assignment and Transfer

By:

All facilities provided under this tariff are directly or indirectly controlled by Custom Teleconnect and neither the Customer nor Subscriber may transfer or assign the use of service or facilities without the express written consent of the Company. All regulations and conditions contained in this tariff shall apply to all such permitted assignees or transferees, as well as all conditions of service. Such transfer or assignment, when permitted, shall only apply where there is no interruption of the use or location of the service or facilities.

#### SECTION 2 - RULES AND REGULATIONS, (CONT'D.)

# 2.5 Liability of the Company

By:

- **2.5.1** The liability of the Company for any claim or loss, expense or damage (including indirect, special, or consequential damage) for any interruption, delay, error, omission, or defect in any service, facility or transmission provided under this Tariff shall not exceed an amount equivalent to the proportionate charges to the Customer for the period of service or the facility provided during which such interruption, delay, error, omission, or defect occurs.
- 2.5.2 The Company shall not be liable for any claim or loss, expense, or damage (including indirect, special, or consequential damage), for any interruption, delay, error, omission, or other defect in any service facility, or transmission provided under this Tariff, if caused by any person or entity other than the Company, by any malfunction of any service or facility provided by any other carrier, by any act of God, fire, war, civil disturbance, or act of government, or by any other cause beyond the Company's direct control.
- 2.5.3 The Company shall not be liable for, and shall be fully indemnified and held harmless by Customer or other users of its service against any claim or loss, expense, or damage, (i) for defamation, invasion of privacy, infringement of copyright or patent, unauthorized use of any trademark, trade name, or service mark, unfair competition, interference with or misappropriation or violation of any contract, proprietary or creative right, or any other injury to any person, property, or entity arising from the material data, information, or content revealed to, transmitted, processed, handled, or used by Company under this Tariff, or (ii) for connecting, combining, or adapting Company's facilities with Customer's apparatus or systems, or (iii) for any act or omission of the Customer, or (iv) for any personal injury or death of any person, or for any loss of or damage to Customer's premises or any other property, whether owned by Customer or others, caused directly or indirectly by the installation, maintenance, location, condition, operation, failure or removal of equipment or wiring provided by the Company if not directly caused by negligence of the Company.
- **2.5.4** The Company shall not be liable for any claim, loss, or refund as a result of theft or unauthorized use of Authorization Codes issued for the use of the Company's services.

#### **SECTION 2 - RULES AND REGULATIONS, (CONT'D.)**

### 2.6 Billing and Payment for Service

#### 2.6.1 Payment Arrangements

The Customer is responsible for payment of all charges for services and equipment furnished to the Customer for transmission of calls via the Company. The Customer agrees to pay to the Company or its authorized agent any cost(s) incurred as a result of any delegation of authority resulting in the use of his or her communications equipment and/or network services which result in the placement of calls via the Company. The Customer agrees to pay the Company or its authorized agent any and all cost(s) incurred as a result of the use of the service arrangement, including calls that the Customer did not individually authorize.

All charges due by the Customer are payable to the Company or any agency duly authorized to receive such payments. Terms of payment shall be according to the rules and regulations of the agency and subject to the rules of regulatory agencies, such as the Federal Communications Commission. Any objections to billed charges must be promptly reported to the Company or its billing agent. Adjustments to Customers' bills shall be made to the extent that circumstances exist which reasonably indicate that such changes are appropriate.

Charges for installations, service connections, moves, and rearrangements, where applicable, are payable upon demand by the Company or its authorized agent. The billing thereafter will include recurring charges and actual usage as defined in this Tariff.

### **SECTION 2 - RULES AND REGULATIONS, (CONT'D.)**

### 2.6 Billing and Payment for Service, (Cont'd.)

#### 2.6.2 Deposits

The Company does not require Customer deposits.

# 2.6.3 Advance Payments

The Company does not require Advance Payments.

### 2.6.4 Late Payment Fees

A late payment fee of 1.5% per month will be charged on any past due balance. Any applicable late payment fees will be assessed according to the terms and conditions of the Company or its billing agent and pursuant to Federal Communications Commission law.

### 2.6.5 Return Check Charge

By:

A return check charge of \$25.00 will be assessed for checks returned for insufficient funds. Any applicable return check charges will be assessed according to the terms and conditions of the billing entity and pursuant to United States law and Federal Communications Commission regulations.

### **SECTION 2 - RULES AND REGULATIONS, (CONT'D.)**

### 2.6 Billing and Payment for Service, (Cont=d.)

### 2.6.6 Billing Dispute

- Any objections to billed charges must be reported to the Company or its billing agent in writing within twenty (20) days of the closing date printed on the invoice or statement issued to the Customer. Disputes may be submitted orally or in writing. Adjustments to Customers' account shall be made to the extent that circumstances exist which reasonably indicate that such changes are appropriate.
- .2 Late payment fees will not be applied during the period when a bill is disputed regardless of the outcome of the dispute.
- .3 Customers may contact the Company's business office at the following toll-free number: 1-800-685-2138.
- .4 If the Customer is not satisfied with the outcome of the billing dispute, the Customer may file a complaint with the Federal Communications Commission.

#### SECTION 2 - RULES AND REGULATIONS, (CONT'D.)

### 2.7 Taxes, Surcharges and Utility Fees

- 2.7.1 All state and local taxes (e.g., gross receipts tax, sales tax, municipal utilities tax) are not included in the rates under this tariff, but shall be listed as separate line items on the Customer's bill.
- 2.7.2 To the extent that a municipality, other political subdivision or local agency of government, or Commission imposes upon and collects from the Company a gross receipts tax, occupation tax, license tax, permit fee, franchise fee, or regulatory fee, such taxes and fees shall, insofar as practicable and allowed by law, be billed pro rata to Customers receiving service from the Company within the territorial limits of such municipality, other political subdivision or local agency of government.
- **2.7.3** The Company may adjust its rates and charges or impose additional rates and charges on its Customers in order to recover amounts it is required by governmental or quasi-governmental authorities to collect from or pay to others in support of statutory or regulatory programs. Such adjustments shall be listed in this tariff.

#### 2.7.4 Universal Service Fund

By:

In connection with the FCC's Universal Service Orders, Custom Teleconnect will pay a percentage of its retail revenues to support the Universal Service Fund ("USF"). Custom Teleconnect will pass-through the USF assessment to its Customers by assessing a surcharge applicable to all interstate and international usage charges, exclusive of taxes. This surcharge is in addition to standard tariffed usage charges and any applicable service charges and surcharges associated with the Company's service. The percentage shall be as dictated by the FCC and adjusted periodically in accordance with FCC requirements.

#### 2.7.4 Public Telephone Surcharge

In order to recover the Company's expenses to comply with the FCC's pay telephone compensation plan effective on October 7, 1997 (FCC 97-371), an undiscountable per call charge is applicable to all interstate, intrastate and international calls that originate from any domestic pay telephone used to access the Company's services. This surcharge, which is in addition to standard tariffed usage charges and any applicable service charges and surcharges associated with the Company's service, applies for the use of the instrument used to access The Company service and is unrelated to the Company service accessed from the pay telephone.

Pay telephones include coin-operated and coinless phones owned by local telephone companies, independent companies and other interexchange carriers. The Public Pay Telephone Surcharge applies to the initial completed call and any reoriginated call (i.e., using the A#@symbol).

Whenever possible, the Public Pay Telephone Surcharge will appear on the same invoice containing the usage charges for the surcharged call. In cases where proper pay telephone coding digits are not transmitted to the Company prior to completion of a call, the Public Pay Telephone Surcharge may be billed on a subsequent invoice after the Company has obtained information from a carrier that the originating station is an eligible pay telephone.

The Public Pay Telephone Surcharge does not apply to calls placed from pay telephones at which the Customer pays for service by inserting coins during the progress of the call.

### 2.8 Obligations of the Aggregator

When service is provided to the transient public through an Aggregator, the Aggregator must post on or near the telephone instrument in plain view of Consumers:

- (A) name, address and toll-free telephone number of Operator Service Company;
- (B) a written disclosure that the rates for all operator-assisted calls are available on request, and that Consumers have a right to obtain access to the interstate common carrier of their choice and may contact their preferred interstate common carriers for information on accessing that carrier's service using that telephone; and
- (C) the name and address of the enforcement division of the Common Carrier Bureau of the FCC, to which the Consumer may direct complaints regarding operator services.

Aggregators must ensure that each of its telephones pre-subscribed to Operator Service Company allows the Consumer to use "800," "950," and 10XXX (where feasible) access code numbers to obtain access to the provider of operator services desired by the Consumer.

No charge by the Aggregator to the Consumer for using an "800" or "950" access code number, or any other access code number, may be greater than the amount the aggregator charges for calls placed using the pre-subscribed provider of operator services (Operator Service Company.)

Aggregators must comply with any access requirements or rules that the FCC sets forth.

#### **SECTION 2 - RULES AND REGULATIONS, (CONT'D.)**

#### 2.9 Refunds or Credits for Service Outages or Deficiencies

#### 2.9.1 Interruption of Service

Credit allowances for interruptions of service which are not due to the Company's testing or adjusting, to the negligence of the Customer, or to the failure of channels, equipment or communications systems provided by the Customer, are subject to the general liability provisions set forth in Section 2.5 herein. It shall be the obligation of the Customer to notify the Company immediately of any interruption in service for which a credit allowance is desired by Customer. Before giving such notice, the Customer shall ascertain that the trouble is not within his or her control, or is not in wiring or equipment, if any, furnished by the Customer and connected to the Company's terminal. Interruptions caused by Customer-provided or Company-provided automatic dialing equipment are not deemed an interruption of service as defined herein since the Customer has the option of using the long distance network via local exchange company access.

Credit allowances for interruptions of service billed on a usage basis shall be limited to the rate applicable to the initial period of the call to compensate for re-establishment of the connection.

#### 2.9.2 Inspection, Testing and Adjustment

Upon reasonable notice, the facilities provided by the Company shall be made available to the Company for such tests and adjustments as may be deemed necessary for maintenance in a condition satisfactory to the Company. No interruption allowance will be granted for the time during which such tests and adjustments are made.

### **SECTION 2 - RULES AND REGULATIONS, (CONT'D.)**

### 2.10 Interconnection with Aggregator

The Company's facilities and service may be used with or terminated in Aggregator-provided terminal equipment or Aggregator-provided communications systems, such as a telephone set, PBX, pay phone or key system. Such terminal equipment shall be furnished and maintained at the expense of the Aggregator, except as otherwise provided. The Aggregator is responsible for all costs at his or her premises, including personnel, wiring, electrical power, and the like, incurred in the use of the Company's service. When such terminal equipment is used, the equipment shall comply with the generally accepted minimum protective criteria standards of the telecommunications industry as endorsed by the Federal Communications Commission.

#### 2.11 Installation and Termination

Service is installed upon mutual agreement between the Aggregator and the Company. The service agreement does not alter rates specified in this tariff.

### **SECTION 2 - RULES AND REGULATIONS, (CONT'D.)**

# 2.12 Cancellation or Termination of Service by Customer

Customers may cancel service verbally or in writing at any time. The Company shall hold the Customer responsible for payment of all charges, including fixed fees, surcharges, etc., which accrue up to the cancellation date. Charges may be avoided by dialing another carrier's access code. In the event the Customer executes a term commitment agreement with the Company, the Customer must cancel service and terminate the agreement in accordance with the agreement terms.

#### 2.13 Refusal or Discontinuance by Company

2.13.1 Service may be suspended by the Company, without notice to the Customer, by blocking traffic to certain cities or NXX exchanges, or by blocking calls using certain authorization codes, when the Company deems it necessary to take such action to prevent unlawful use of its service. CTI will restore services as soon as it can be provided without undue risk, and will, upon request by the Customer, assign new authorization codes to replace ones that have been deactivated.

#### **SECTION 2 - RULES AND REGULATIONS, (CONT'D.)**

# 2.13 Refusal or Discontinuance by Company, (Cont'd.)

- **2.13.2** The Company may refuse or discontinue service under the following conditions provided that, unless otherwise stated, the Customer shall be given notice to comply with any rule or remedy any deficiency:
  - A. For nonpayment of undisputed charges, provided that suspension or termination of service shall not be made without five (5) days notice to the Customer, except in extreme cases. Such notice will be provided in a mailing separate from the Customer's regular monthly bill for service.
  - **B**. For non-compliance with or violation of any State, Municipal, or Federal law, ordinance or regulation pertaining to telephone service.
  - **C**. For use of telephone service for any purpose other than that described in the application.
  - **D.** For neglect or refusal to provide reasonable access to Custom Teleconnect or its agents for the purpose of inspection and maintenance of equipment owned by Custom Teleconnect or its agents.
  - E For noncompliance with or violation of Commission regulation or Custom Teleconnects rules and regulations on file with the Commission.
  - **F.** Without notice in the event of Customer, Subscriber or Authorized User use of equipment in such a manner as to adversely affect Custom Teleconnects equipment or service to others.

### **SECTION 2 - RULES AND REGULATIONS, (CONT'D.)**

# 2.13 Refusal or Discontinuance by Company, (Cont=d.)

- **G.** Without notice in the event of tampering with the equipment or services owned by Custom Teleconnect or its agents.
- **H.** Without notice in the event of unauthorized or fraudulent use of service. Whenever service is discontinued for fraudulent use of service, Custom Teleconnect may, before restoring service, require the Customer or Subscriber to make, at his or her own expense, all changes in facilities or equipment necessary to eliminate illegal use and to pay an amount reasonably estimated as the loss in revenues resulting from such fraudulent use.
- **I.** Without notice by reason of any order or decision of a court or other government authority having jurisdiction that prohibits Company from furnishing such services.

### **SECTION 2 - RULES AND REGULATIONS, (CONT'D.)**

# 2.14 Cost of Collection and Repair

Customer is responsible for any and all costs incurred in the collection of monies due the Company including legal and accounting expenses. The Customer is also responsible for recovery costs of Company-provided equipment and any expenses required for repair or replacement of damaged equipment.

#### 2.15 Other Rules

By:

The Company reserves the right to discontinue service, limit service, or to impose requirements on Customers as required to meet changing regulatory rules and standards of the Federal Communications Commission.

#### **SECTION 3 - SERVICE DESCRIPTIONS AND RATES**

#### 3.1 General

By:

Custom Teleconnect provides operator services for communications originating and terminating within the United States. The Company's services are available twenty-four (24) hours per day, seven (7) days a week. Intrastate service is offered in conjunction with interstate service.

Customers are charged individually for each call placed through the Company's network. Charges may vary by service offering, mileage band, class of call, time of day, day of week and/or call duration. Customers are billed based on their use of Custom Teleconnects services and network.

### **SECTION 3 - SERVICE DESCRIPTIONS AND RATES, (CONT'D.)**

### 3.2 Timing of Calls

Billing for calls placed over the Custom Teleconnect network is based in part on the duration of the call as follows, unless otherwise specified in this tariff:

- **3.2.1** Timing of each call begins when the called station is answered (i.e. when two-way communications are established). Answer detection is based on standard industry answer detection methods, including hardware and software answer detection.
- 3.2.2 Chargeable time for calls ends when one of the parties disconnects from the call.
- **3.2.3** The initial and additional billing increments are stated in the description of the service.
- **3.2.4** The Company will not knowingly bill for unanswered calls. When a Customer indicates that he/she was billed for an incomplete call, the Company will reasonably issue credit for the call.

#### 3.3 Rate Periods

By:

The Company does not rate calls based on time-of-day.

### 3.5 Operator Assisted Calling

Operator Assisted Calling is available for use by transient end users from Aggregator locations. Calls are billed in two increments. The first is a usage increment in which charges accrue based on duration of the call. The second is a per call component reflecting the level of operator assistance and billing method.

Calls may be originated via traditional operator services access (0+ or 0) or via a Company-designated access number.

The Company offers many operator service rate plans depending upon the needs of a particular Aggregator location. The types of calls handled are as follows:

<u>Calling Card Calls</u> - This option allows a Customer to bill the call to an authorized Calling Card or Commercial Credit Card. For calls made using a telephone company card, acceptance of the card will be dependent upon the Company's ability to verify the card as valid. Only those cards accepted by the Company may be used for Operator Services.

<u>Collect Calls</u> - This option enables a call to be billed to the called number, provided that the called station accepts responsibility for payment of charges. Collect calls may be station-to-station and therefore accepted by any party at the called location or Person-to-Person where a specific party is requested at the called party and charges can only be accepted by the requested party.

<u>Third Party Billed Calls</u> - this option allows a called to be billed to a number other than the originating or terminating telephone number. The Company reserves the right to verify acceptance of charges prior to billing charges to a third party number.

<u>Person-to-Person</u> - This charge applies in addition to usage charges for calls placed with the assistance of a Company operator to a particular party at the destination number. This charge applies regardless of billing method, including but not limited to billing to a Calling Card, Commercial Credit Card, Collect, by deposit of coins in Pay Telephones, or to a Third Party. Charges do not apply unless the specified party or an acceptable substitute is available.

#### **SECTION 4 - COMMISSIONS, SURCHARGES AND FEES**

#### 4.1 Commissions

No commissions are collected from the Customer in addition to the charges specified in Sections 3 and 4.2 and 4.3 of this tariff.

### 4.2 Property Surcharges

At the option of the Aggregator, a per-call Property Surcharge may apply for the use of the Aggregator's telecommunications facilities and equipment. The Company reserves the right to limit the amount of the surcharge within the range as shown below. Customers will be notified of any applicable Property Surcharge per Commission rules.

#### SECTION 5 - CONTRACTS AND PROMOTIONS

#### **5.1** Contracts - General

At the option of the Company, service may be offered on a contract basis to meet specialized requirements of the Customer not contemplated in this tariff. From time to time the Company may demonstrate service for potential Customers by providing free use of its network on a limited basis for a period of time, not to exceed three (3) months. Demonstration of service and the type, duration or quantity of service provided will be at the Company's discretion.

#### 5.3 Promotions
